ANNUAL GENERAL MEMBERSHIP MEETING

The Annual General Membership (AGM) Meeting of Westwind Club Association Limited will be held on Tuesday, July 14, 2026, at 2:00 pm in the clubhouse at the Westwind Club facilities in Nassau, Bahamas. All members in good standing are invited to attend.

A Proxy is a legal document whereby you, as an owner in good standing, can assign your vote to another owner in good standing or a member of the Board of Directors who will attend the Annual General meeting and vote your share for you. You have one vote for each week that you own, and you can specify who will vote your share and, if you wish, you can direct this person to vote as you wish on any issue. **As our staff does not own weeks at Westwind Club, please do not assign your Proxy vote to one of them. Also, if you are not going to attend the Annual General Meeting, do not assign yourself as your Proxy. If you do, your vote will not be exercised.**

If you are unable to attend, we request that you complete and send your Proxy appointing a board member, whose names and addresses are on the last page of the newsletter and available on the website. Or, you may send to another owner who will be attending the AGM in person to cast your vote (s).

I would like to take this moment to provide you with the status of maintenance payments:

We have your payments mailed to a central receiver, which currently is the PO Box in my hometown in Wisconsin; this is due to the unreliable mail service in the Bahamas. Each and every check received at the PO Box is recorded by me and then held for approximately one month before sending via FedEx all that have been received within that timeframe.

With Maintenance Invoices sent out in October, the first FedEx package was delivered to the club the first week of November. Each month after that, a total of another 5 FedEx packages were delivered to the club, with the last arriving at the club on April 1. For transparency, the average cost of a FedEx package to the club is approximately \$125 - \$150 depending on weight. For comparison, I was in Naples, FL recently and I checked how much a one-pound package to be delivered to the club would cost – I was shocked to find out it would cost \$100.

Currently with no US Banking options available to us at this time due to Bahamian banking rules, we continue to look at options for a more efficient manner to deposit payments and to make payments to owners, whenever necessary. Any and all checks received prior to March 31 have been sent to the club and have been received by the club. If you are uncertain about the status of a payment you may have sent, please contact me at eric@westwindclub1.net. As of this writing, I have received only one additional check since March 31.

I look forward to seeing some of you at the club this July and whenever else I may be fortunate enough to be at the club!

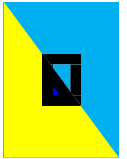
